## Notes

1. While the school's academic year is from April to March, admissions can happen at any time of the year subject to seat availability.
2. The date of determining the age eligibility is 1st April of the joining year.
3. Meals are included in the Composite Fee.
4. For Day Care opted on a per day basis, the fee shall be INR 1800 (upto 3 hours) and INR 2300 (beyond 3 hours) per day.
5. The fee for the Holding Hands programme is INR 1500 per class.
6. The Day Care fee during the summer/winter holidays is INR 30,000 per month for Full Day Care (8:30 am to 6:00 pm) and INR 20,000 per month for Half Day Care (9:00 am to 2:00 pm).
7. Rebates:
  - a. Annual Payment Rebate: 5% rebate on the Composite Fee if all fee components for the entire year are paid upfront by 15th May.
  - b. Sibling Rebate: 10% rebate on the Composite Fee for the younger sibling(s) until the time an elder sibling continues to be enrolled in the school.
  - c. Alumni Child Rebate: 50% rebate on the Admission Fee.
8. Payments not received by the 'Pay By Date' shall attract a late fee penalty @ 2% per month on the outstanding amount. Payments not received within 45 days of the 'Pay By Date' shall result in the cancellation of enrolment.
9. Withdrawals from the School can only happen at the end of a quarter and must be intimated by the 15th of the last month of each quarter. Withdrawal intimations after the said dates shall result in the forfeiture of the Refundable Security Deposit.
10. Payments can either be made online by visiting [www.pathwaysgurgaon.edu.in/fee-payment](http://www.pathwaysgurgaon.edu.in/fee-payment) or through a cheque/draft issued in favour of 'Pathways Early Years Golf Course Road Revenue Account'. In case of payments via cheque/demand draft, the student's name and ID number must be clearly mentioned on the reverse side.
11. If a Pathways Early Years student applies for and secures admission in one of the Pathways K-12 schools, the one-time admission fee and security deposit paid earlier shall be adjusted and only the differential amount shall be payable.
12. The Fee Structure of Pathways Early Years is governed by the rules, policies, terms and conditions as detailed in the Parent Student Handbook, as amended from time to time by the school management at its sole discretion.
